- (a) Illegal logging or the trade in illegal wood or forest products;
- (b) Violation of traditional and human rights in forestry operations;
- (c) Destruction of high conservation values in forestry operations;
- (d) Significant conversion of forests to plantations or non-forest use;
- (e) Introduction of genetically modified organisms in forestry operations;
- (f) Violation of any of the ILO Core Conventions as defined in the ILO Declaration on Fundamental Principles and Rights at Work.

The company's commitment shall be made available to the staff/workers, suppliers, customers and other interested parties.

TRANSLATION FOR POLICY FOR ASSOCIATION WITH FSC AND PEFC

TERJEMAHAN

Dasar untuk Persatuan dengan FSC dan PEFC

Nibong Tebal Paper Mill Sdn. Bhd. (NTPM) berikrar untuk menjadi sebuah syarikat yang bertanggungjawab terhadap alam sekitar dengan mematuhi keperluan undang-undang dan peraturan-peraturan alam sekitar, mencegah pencemaran kepada alam sekitar dan terus menambah baik proses pembuatan kami untuk memelihara alam sekitar.

Kami mematuhi nilai FSC (Forest Stewardship Council) dan PEFC (Program for the Endorsement of Forest Certification). Kami tidak akan terlibat secara langsung atau tidak langsung dalam aktiviti-aktiviti yang tidak boleh diterima dalam mendapatkan sumber bahan mentah kami: -

- (a) Pembalakan haram atau perdagangan kayu haram atau hasil hutan haram;
- (b) Pelanggaran hak tradisional dan hak asasi manusia dalam operasi perhutanan;
- (c) Pemusnahan nilai hutan yang tinggi dalam operasi perhutanan;
- (d) Pertukaran ketara hutan kepada ladang atau penggunaan bukan hutan;
- (e) Pengenalan organisme yang diubah suai secara genetik dalam operasi perhutanan;
- (f) Pelanggaran mana-mana Konvensyen Teras ILO sebagaimana yang ditakrifkan dalam Deklarasi ILO atas Prinsip dan Hak Asasi di Tempat Kerja.
